Dear Sgt. Vieth,

I hope DC is warm and things have calmed down a bit. I have what should be a quick question for you. Is there a Special Agent contact name in the Threats Assessment Investigation Division that has inherited my disaster?
Or should I send US mail to the attention of Special Agent Van Alstine?

I know you have switched units however I have sent a few communications to threats@uscg.gov and did not receive a response. There was a very weird communication that came to me from the White House, Office of Presidential Correspondence and because of its weird nature I want to forward documents I feel should be in my case file. It is a very not understandable communication which included a check for approx. \$1300! That had no sensible reason to be sent to me as it is not payable to me, nor do I have any rights to any money nor have I ever donated any money to Obama or any campaign that would be subject to return. It does, on the most basic level, confirm that the WHITE HOUSE does have my exact contact information.

I sent a letter with the error made by the WHITE HOUSE and they again sent me back the check with attachments. If you want to visit the communications please visit www.shaunod.us/WHITEHOSUE.pdf.

I am ever so conscious of any US CAPITOL POLICE mobilization or situation in the news because of your response on the BOLO for my detainment. 30, 50 however many marked/unmarked/CERT/other agency units responded still has me in awe at how fast they converged upon me.

In my personal situation because you were so encouraging it is good news. I am nearing the end of the HEP C regiment of new medications and it looks like a 99.8% cure for my life threatening medical condition which cost over \$189,000 in

medication costs covered by my Medicare. Oddly, in medical topics Psychiatric Institute of Washington (PIW). never charged my insurance and three certified communications on the payee for that visit have gone unanswered, nor did the ambulance transport. They both took my insurance card information. CPEP was charged off to the DC DMHRS and not billed to my insurance.

I am still in awe at your professionalism, respect, and integrity. I hope your new position gives you the change you were looking for. Stay safe and I commend you of your service. I don't think many people realize the responsibility you have and how in a second situations can go to the catastrophic level.

In my ordeal your almost instantaneous up-lifting responses made me feel not forgotten. Also, Van Alstine's kudos of my accomplishments means as much to me as the early in life FBI Commendation.

I might make a vacation visit during the US CAPITOL PRIDE events I will effectively communicate in advance to the US CAPITOL POLICE (as requested per Van Alstine that I notify you in advance of DC trips).

My regards to you, Special Agent Van Alstine and all those who helped me. Sorry for the lengthy email to catch you up to date!
