I was a **CHELMSFORD PUBLIC SCHOOL** student certified Chapter 766 Learning Disabled / Special Needs from South Row School to which I am trying to obtain written confirmation of such certification. I was Chapter 766 from approximately Grade 2 throughout my public school education. I graduate in 1986 from **CHELMSFORD HIGH SCHOOL** on time.

This information is being requested because I am in the concept stages with a book publicity agent on a book detailing my life successes and challenges with a late in life diagnosis of Bipolar and ADHD which traces back to my Chapter 766 Learning Disability, Consistent with Bipolar, and in part because of my **CHELMSFORD PUBLIC SCHOOL** education, you prepared me to achieve great success. I received a written Commendation from the Director of the Federal Bureau of Investigation, William Sessions for my instrumental involvement in the successful recovery of a 5 year old kidnap victim from Milford, Massachusetts at age 21. I then went on to earning over six figures at a global advertising agency, DIGITALS to which I had an approximately ten year tenure. In the negative, I had outstanding bounced check warrants that latest approximately 20 years!

As a matter of fact checking this information may need to be confirmed therefore I am requesting any such record that the **CHELMSFORD PUBLIC SCHOOL** system has of such determination and my scholarship. I believe I was referred for testing by Ms. Grey in Grade 2 and tested by Ms. Simple at South Row School. My graduation was publicized in the **CHELMSFORD INDEPENDENT** as well as my scholarship award.
